

Registration

- The registration at the head office or goods receipt/issue must be done after arriving and before leaving the company area.
- Visitors will be added in a registration list.
- The contact person of Jura-Guss GmbH will meet you at the registration and in the end brings you back.
- If you plan an extraction of energy (current, gas, compressed air) in relevant amount please signal at registration.

Traffic regulations

- The traffic regulations (StVO) apply on the company area. Person and forklift traffic have priority. Additional internal company traffic and behavioral rules (e.g. maximum speed, passage and stopping restriction) visible by signs must be considered.
- „Slow speed“ on the company area.
- The maximum speed is 10 km/h.
- Parking of vehicles is only allowed at the marked parking places.
- Fire department-access, extinguishing devices, traffic areas, emergency exits, manhole cover and all accesses and exits of the company area are permanently keep free.



Additional rules for loading and unloading

- Before access the company area you need following equipment in your vehicle: reflective vest according EN 471 und safety shoes according DIN EN ISO 20345.
- **Reflective vest** and **safety shoes** must be worn before leaving the vehicle.
- Hazards of reserve driving must be considered.

Safety information

- It is forbidden to take photos and videos on the company area (also for mobile phones). An individual agreement to make photos could be discussed with Jura-Guss GmbH.
- Alcohol and intoxicant substances restriction: The owning and using of alcohol and intoxicant substances is restricted. Affected persons are not allowed to access the company area.
- Fire and open light is restricted.
- In some marked areas you have to use personal safety equipment as it is visible.
- There is a general smoking prohibition on our company. Smoking is only allowed on separat designated smoking areas.
- Wearing of safety shoes is necessary in the production areas.
- Stay only in areas, which are entitled by your contact person of Jura-Guss GmbH.
- The contact with machines and systems and all parts is restricted. Employees should not be interrupted during their work.
- Do not stay in the area of cranes or suspended loads.
- Do not have contact with aluminum alloyed part before you have permission by a person of Jura-Guss GmbH.



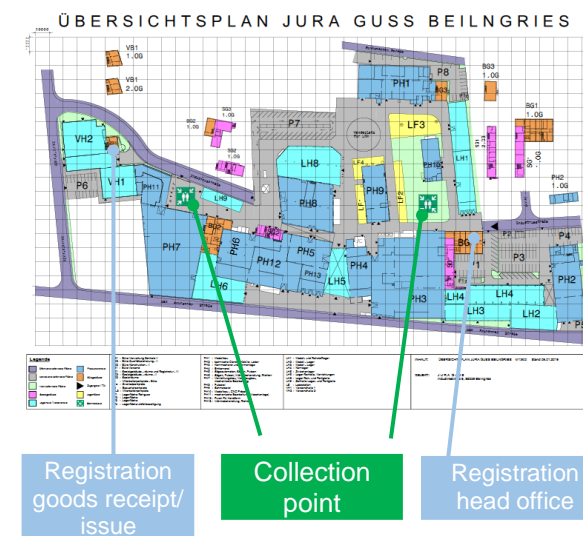
Environmental safety
